## **UNDERSTANDING UPCOMING CHANGES TO CONTACT LENS LABELS: WHAT EYE CARE PROFESSIONALS NEED TO KNOW**

To improve patient safety and tracking of medical devices, including contact lenses, the European Union is introducing the **Unique Device Identifier (UDI) system**. This new system includes the ability to trace medical devices throughout their lifecycle.

### **Contributing to contact lens traceability: new regulatory requirements for Eye Care Professionals**

Eye Care Professionals (ECPs) play a key role in ensuring the traceability of contact lenses. As a distributor of medical devices, ECPs are responsible for verifying that a UDI has been assigned by the manufacturer before making the lens available to patients.

For contact lenses, this means a **Master UDI (MUDI)**, a unique identifier assigned to a group of lenses with common attributes.

### **New barcodes on contact lens labels for better traceability**

By 9 **November 2025**, all contact lens labels will include Master UDI information in 2 formats:

- **Automatic Identification and Data Capture (AIDC):** A machine-readable format, such as a 2D data matrix barcode.
- **Human Readable Interpretation (HRI):** A plain-text version of the MUDI information.

This means that, for example with standard contact lenses, the Master UDI can be identified either by scanning the data matrix or by reading the numbers following the mention **“(8014)”** on the packaging.



Depending on the current labeling practices, the following updates will occur:

- If a barcode **already exists** on the label, the Master UDI code will be incorporated into it.
- If **no AIDC (e.g. barcode)** is currently present, a new AIDC containing all information, including the Master UDI, will be added.

advisable to **check with the software provider** to confirm compatibility and identify any necessary updates.

During the transition period, ECPS may come across both **old and new labeling formats**. Being prepared to handle both will help ensure a smooth adaptation.
